I confirm that I am knowingly and willingly arranging a session with J. Moor involving traditional corporal punishment, disciplinary spanking, and/or consensual role-play of an adult and potentially erotic nature, with full understanding and informed consent.

I am fully aware of and comfortable with the nature of this arrangement, and I grant J. Moor my clear and voluntary permission to proceed with spanking activities that fall within the scope of my chosen preferences.

I also acknowledge that J. Moor is not a professional disciplinarian, and that this is a non-commercial interaction — no financial exchange is involved.

Finally, I confirm that I have personally arranged for J. Moor to meet me at a location of my choice, whether it be my private residence, hotel room, or other suitable space, for the sole purpose of administering consensual corporal punishment and discipline. All activity will take place within the personal limits, comfort zones, and boundaries I have communicated, and with my full, informed, and voluntary consent.

Health Acknowledgement

I confirm that I have shared all relevant details about my medical history, including any conditions that could pose a risk during corporal punishment or spanking activities, with J. Moor prior to participating in any such session.

I affirm that I am in good physical health and capable of receiving consensual corporal punishment or spanking discipline. I understand and accept that any activity will be conducted within the personal boundaries, limits, comfort level, and pain tolerance I have clearly communicated.

To the best of my knowledge, there are no health concerns, including but not limited to cardiovascular issues such as high blood pressure, that would make participation unsafe or inadvisable.

With full understanding and of my own volition, I give J. Moor my consent to proceed with disciplinary spanking within the boundaries I have set.
